

**ORDINANCE NO. 5
SERIES 2005**

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF GUNNISON AMENDING CHAPTER 2, ARTICLE 1, SECTION 1, OF THE CITY CODE OF THE CITY OF GUNNISON, COLORADO, PROVIDING AN INCREASE IN SALARIES FOR THE MAYOR AND COUNCILMEMBERS; AND PER SECTION 3.17 OF THE CITY OF GUNNISON MUNICIPAL HOME RULE CHARTER, SETTING AN INCREASE IN THE COMPENSATION OF THE PLANNING & ZONING COMMISSIONERS, ZONING BOARD OF ADJUSTMENT AND APPEALS MEMBERS, AND BUILDING BOARD OF APPEALS MEMBERS

WHEREAS, the City Council of the City of Gunnison, Colorado, recognizes and appreciates the dedication and hard work exhibited by its elected City Council Members and its appointed Board and Commission Members; and

WHEREAS, the City Council of the City of Gunnison, wishes to increase the compensation of its elected City Council Members and appointed Board and Commission Members.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF GUNNISON, COLORADO, ORDAINS THAT:

Section 1. Section 2-1-1 of the City Code of the City of Gunnison is hereby amended to read: **Council and Mayor Compensation**. Each Councilmember of the City shall receive a salary of Five Hundred and no/100 Dollars (\$500.00) per month, except the Mayor, whose salary shall be Six Hundred and no/100 Dollars (\$600.00) per month, all such salaries to be paid out of the General Fund of said City as budgeted, appropriated, and directed by the City Council.

Section 2. Each member of the Council-appointed Planning & Zoning Commission, Zoning Board of Adjustment and Appeals and the Building Board of Appeals, shall receive compensation in the amount of Fifty and no/100 Dollars (\$50.00) per meeting.

Section 3. Effective Date; Applicability Limited. The compensation increases granted and allowed hereby shall become effective on January 1, 2006, with respect to those officers elected at the regular municipal election May 10, 2005, and thereafter, and also those officers whose terms shall not have expired on said date, all in accordance with Section 3.3 of the City of Gunnison Municipal Home Rule Charter; and to those appointed Commission and Board Members serving as of January 1, 2006.
