

**ORDINANCE NO. 6
SERIES 2009**

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF GUNNISON AMENDING THE MONTHLY RATES CHARGED BY THE CITY OF GUNNISON PUBLIC WORKS DEPARTMENT FOR REFUSE AND RECYCLING SERVICES.

WHEREAS, Section 9.2 of the City of Gunnison Municipal Home Rule Charter requires that rates charged for utility services be at least sufficient to pay the costs of operation of such services and to replace, when necessary, obsolete equipment used therein; and

WHEREAS, the City Manager of the City of Gunnison has recommended to the City Council a revision to the rates charged by the City of Gunnison Department of Public Works for the operation of the City's refuse and recycling services.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF GUNNISON, COLORADO, ORDAINS THAT:

Section 1. Section 12.40.020(D) of the City Code of the City of Gunnison is hereby amended to read as follows:

12.40.020(D). Refuse/Recycle Collection Rates. The City Council of the City of Gunnison hereby established the following refuse and recycle collection rates within the City of Gunnison:

Refuse/Recycle Rates

Residential Refuse:

Monthly Basic Service Charge*

(1) 38 Gallon Container	\$16.00/Month
(1) 68 Gallon Container	\$20.00/Month
(1) 98 Gallon Container	\$25.00/Month
(1) 2 Yd. Dumpster (4 Home Minimum)	\$25.00/Month/Home

Special Pick-up- Must be in container with the exception of Furniture, Appliances, and Tree Limbs.

(1) 38 Gallon Container	\$4.00/Each
(1) 68 Gallon Container	\$5.00/Each
(1) 98 Gallon Container	\$6.25/Each
(1) Piece of Furniture/Appliance	\$10.00/Each
(1) Refrigerator (Includes Freon Capture)	\$35.00/Each

Residential Recycle: No charge

Commercial Refuse/Recycle:

Monthly Basic Service Charge*

(1) 2 Yd. Dumpster (Refuse)	\$62.00/Month
(1) 2 Yd. Dumpster (Recycle Cardboard)	\$25.00/Month
(1) Maximum 50 Gallon Container of plastic/aluminum tin/paper	\$12.50/Month

Construction Dumpster (Temporary)

(1) 2Yd. Dumpster/Each Pick-up	\$30.00/Pick-Up
(1) Minimum per Month	\$30.00

*Residential Basic Service consists of the weekly pickup of (1) container. Commercial Basic Service consists of the weekly pickup of one two (2) cubic yard dumpster. All Recycle Pick-ups are for (1) Container/Dumpster weekly.
