**CITY OF GUNNISON COUNCIL
SPECIAL SESSION MEETING MINUTES**

7:00 P.M.

Pursuant to Gunnison Municipal Home Rule Charter Section 5.2, this Special Session meeting was called in writing by Mayor Richard Hagan to City Clerk Davidson on November 18, 2015.

The City Council Special Session meeting was called to order at 7:00 P.M., by Mayor Hagan, with Councilors Ferguson, Drexel, and Schwartz present along with City Clerk/Acting City Manager Davidson, Finance Director Cowan, Police Chief Robinson, WSCU Liaison Davis, several citizens and the press. City Attorney Fogo, City Manager Coleman, and Councilor Morrison were absent. A Council quorum was present.

Lou Costello with Colorado Cannabis Cabin arrived later in the discussion and introduced himself. Council thanked all of the applicants for being present.




Roll call vote, yes: Ferguson, Drexel, Hagan, Schwartz. Motion carried.
