**ADVISEMENT**

**You are before the Court because a Police Officer of this City has charged you with a violation of the law.**

**YOU HAVE THE FOLLOWING RIGHTS:**

1. **TO** appear before a Judge.
2. **TO** be advised by the Court of the nature of the charge(s) against you of the maximum penalty.
3. **TO** be presumed innocent of the charge(s), and if you plead Not Guilty, the prosecution must prove you Guilty beyond a reasonable doubt.
4. **TO** bail and to be advised of the amount of bail that has been set by the Court.
5. **TO** not make a statement, but than any statement made can and may be used against you.
6. **TO** be represented by Counsel, and if indigent, the right to appointed Counsel, as applicable.
7. **TO** a continuance of this Arraignment, for good cause shown.
8. **TO** have a trial by a Jury, if such right is granted by ordinance. Such demand must be made in writing and payment of a \$25.00 jury fee must be made within twenty days of entering a Not Guilty plea, unless due to a finding of indigence, the jury fee is waived by the Judge. If you fail to meet conditions, your trial shall be by the Court.
9. **TO** compel the attendance of witnesses on your behalf by subpoenas, issued by the Court, without expense to you.
10. **TO** testify or not testify on your own behalf. Your silence does not imply any wrong doing on your part and cannot be used against you.
11. **TO** appeal any Judgment to the District and Appellate Courts of Colorado, within 30 days of entry of judgment, however, if you plead Guilty, you waive your right to appeal.
12. I further acknowledge that I swear or affirm under penalty of perjury any statements made to the Court are deemed to be under oath and subject to penalty of perjury.
